Underwent a post race veterinary examination revealing swelling to the nearside fore leg. 3 day incapacitation period issued. Stewards had concerns with the greyhounds actions in the home straight, after reviewing the video replay and taking submissions from trainer Mr Robert Harrison stewards were satisfied no rules of racing were breached but notified Mr Harrison future performances will be monitored. |
| 4 Ruby Sky | Checked off the heels of another runner entering the back straight causing the greyhound to lose momentum and shift out. Greyhound continued to yield ground throughout the race. Underwent a post race veterinary examination revealing a nearside stopper ligament injury and offside hip support soreness. 21 day incapacitation period issued. |
