## RACE COMMENTARY

RACE 1	
RYAN'S CLEANING SERVICE MAIDEN, 297m	
<b>2 Hooked Me</b>	Checked by another on its outer in the run into the first turn, yielding ground soon after. Post race veterinary examination by the OTV revealed no apparent injury.
<b>3 Rosa Marie</b>	Post race swab.
<b>4 Keg On Legs</b>	Led early. Came together with two others leaving the back straight, losing momentum and ground. Post race veterinary examination by the OTV revealed no apparent injury.
<b>6 Socks Sassy Girl</b>	Checked off the hindquarters of another leaving the back straight losing momentum and ground. Appeared to be pulling up after passing the 600m starting boxes as it negotiated the entry into the turn. Two post race veterinary examinations were undertaken by the OTV, soon after the race and later in the race meeting, revealing nearside groin soreness and nearside hock soreness for which a 28 day incapacitation period was applied. Stewards conferred with the OTV regrading the injuries found, with regard to their impact on a greyhound entering a turn & the likelihood the injuries, if endured prior to the turn, would have caused the greyhound to prop passing the 600m starting boxes as it did. The OTV concurred and after consultation as a panel, stewards after taking into account all factors including the limited racing career of the greyhound (sixth start) decided to take no further action against the greyhound over and above the 28 day injury standdown.

<b>3 My Monica</b>	Post race swab.
<b>8 Cawbourne Simon</b>	<p>Very slow to begin. Came together heavily with another at the point of the turn into the home straight when making a strong run.</p> <p>Post race, stewards and starter conferred whilst examining starting box 8 for any anomalies that might have impeded the greyhound at the start. No evidence was found. Stewards reviewed the available video replays, concluding the greyhound mistimed the start.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>

<b>LADBROKES RACING CLUB 1-3 WIN, 520m</b>	
<b>1 Slippery Gunn</b>	<p>Fell after finishing, in the run towards the catching pen.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>
<b>5 Miss Tess</b>	<p>Hindquarters galloped on by another in the run into the first turn, down in its hindquarters losing considerable ground at the tail of the field thereafter.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>

<b>RACE 5</b>	
<b>LADBROKES BLACKBOOK MASTERS, 297m</b>	
<b>1 Rock Burner</b>	<p>Post race swab.</p> <p>Stewards conferred with the starter post race regarding the perceived actions of the trainer of this greyhound, Ms.J.Brown immediately prior to the start. The greyhound was apparently fractious in the starting box, Ms Brown stepping forward to touch the roller door of starting box 1 after the green light was displayed, before being directed by the starter to remove her hand from the starting box roller door. She continued to hold the top of the roller door till lidrise.</p> <p>Stewards interviewed trainer Ms.J.Brown re her actions immediately prior to the start. Ms Brown advised she didnt hear the starter's direction to her and wasnt aware what she did to the starting boxes contravened any rules.Stewards took submissions from Mr.E.Taylor the Dapto starter. Stewards reviewed Ms Brown's record of prior penalties for any prior rule breach, finding nil. With the conjecture over what had been said and heard, stewards determined that a reprimand was in order for Ms.Brown and issued one in relation to GAR 105(7), issued under GAR 156(h), reminding her of her obligations once in the hands of the starter to not interfere with the starting boxes or similar without first involving the starter, with his endorsement.</p>
<b>2 My Hacienda</b>	<p>Glanced the running rail at the point of the turn into the home straight. Post race veterinary examination by the OTV revealed no apparent injury.</p>
<b>6 Corless Crazy</b>	<p>Trainer Mr.T.Corless requested a post race veterinary examination by the OTV. The examination revealed no apparent injury.</p>

Post race veterinary examination by the OTV revealed lower back soreness for which a 7 day incapacitation period was applied.

Thought to have cramped post race in the catching pen. Post race veterinary examination by the OTV revealed no apparent injury.

<b>RACE 10</b>	
<b>GREYHOUND PRODUCTS DIRECT, 297m</b>	
<b>5 Ring Burner</b>	Moderately away. Checked leaving the back straight. Approaching the 600m starting boxes checked again, momentarily stumbling in the hindquarters. yielding ground. Glanced the running rail on entering the home straight. Post race veterinary examination by the OTV revealed no apparent injury.

<b>RACE 11</b>	
<b>PBD LADBROKE IT! 1-2 WIN, 297m</b>	
<b>1 Hyped Up Hustler</b>	<p>Checked by another in the back straight and again leaving the back straight, yielding ground. Raced wide rounding the point of the turn into the home straight, colliding heavily with the greyhound on its outer RECLINER KING(2), with head turned outwardly, losing focus on the lure, interest only in RECLINER KING (2).</p> <p>Post race veterinary examination by the OTV revealed no apparent injury. Stewards interviewed trainer Mr.Grech post race after reviewing available race replays. Mr Grech acknowledged to stewards his greyhound had not pursued the lure for the duration of the race. Stewards concluded it was inconclusive from the video repays whether the greyhound had marred. Stewards however found the greyhound had Failed to Pursue the Lure and issued an endorsement in accord with GAR124 for 1st Offence Failing to Pursue the Lure.</p>
<b>2 Recliner King</b>	<p>Slowly away. Prominent leaving the back straight before moving wide past the 600m starting boxes, yielding some ground. Moved wide at the point of the turn into the home straight where HYPED UP HUSTLER (1) collided heavily with it, with its head turned outwardly, both greyhounds losing ground as a result of the impact.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>

**PBD LADBROKES EASY FORM 1-2 WIN, 297m**

<b>3 Mulwee Dave</b>	Moderately away. Hampered off the heels of another leaving the back straight. Moved wide rounding the home turn, yielding some ground, before tacking on to the tail of the field in the home straight. Post race veterinary examination by the OTV at the trainer's request revealed a suspected fracture of the nearside hind sesamoid for which a 60 day incapacitation period was applied.
