1 Black Tsunami	Slow to begin. A pre-race urine sample was obtained.		
3 Angel Shirley	A post-race veterinary examination of the greyhound, which fell at the first turn, revealed a nearside hip support injury, offside wrist, tibia and fibula soreness, and an offside hind abrasion. A 10-day incapacitation period was issued.		
5 Smooth Plane	Passing the winning post was steadied when tightened for room and a short distance later was then bumped and became slightly unbalanced. Soon following this incident, the greyhound became unbalanced and lost ground when hampered by a fallen runner.		
7 One Hot Bandit	Making the first turn was bumped and forced wider, becoming unbalanced. A post-race urine sample was obtained.		
8 Shima Current	Making the first turn was bumped on the hindquarters and became very unbalanced. A post-race urine sample was obtained.
