After considering the submissions made and the result of the post-race veterinary examination it was decided that on this occasion, no formal action would be taken today but the trainer was warned that future performances would be monitored, and any similar behaviour may result in formal action.</p>

A post race veterinary exam revealed no apparent injury. Trainer, Ike McCorkingdale was questioned regarding the performance of the greyhound. Mr McCorkindale was disappointed with the performance and advised he was considering retiring the greyhound for breeding. After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Unsatisfactory Performance under GAR 129. and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.
