5 CALLAWAY BEACH - a post-race swab sample was collected.

6 GLENREAGH SPUD - checked rounding the 1st turn.

7 BUMPY BILL – checked and fell rounding the 1st turn. Underwent a post-race Veterinary examination which revealed no obvious injuries.

8 OH SO ORSON - checked rounding the 1st turn.

RACE 2 HICK'S BUSINESS SERVICES MAIDEN 314m

1 STAR MOMENT – checked entering the front straight.

2 BLUE WHISTLE - checked approaching the 1st turn.

3 MELLENCAMP - a post-race swab sample was collected.

4 PRINCE STIMO – checked rounding the turn out of the back straight. Underwent a post-race Veterinary examination which revealed it to have injured its off fore pin and was stood down from racing for 10 days.

5 GAGAN STACEY LEE - checked approaching the 1st turn.

7 LIKE A THIEF - checked and fell approaching the 1st turn. Underwent a post-race Veterinary examination which revealed it to have fractured its near wrist and was stood down from racing for 60 days. The Greyhound was transported to the Belmont Veterinary Clinic for clinical assessment and further treatment.

1 RUBY SANNETTE - checked shortly after the start.



2 SYMI FORTUNA - checked shortly after the start. Underwent a post-race Veterinary examination which revealed have an abrasion to its near fore stopper pad and was stood down from racing for 10 days.

3 BANJO'S RIVAL - checked shortly after the start.

4 TAN CAN GO - checked shortly after the start.

6 REDBANK MOLLY - Underwent a post-race Veterinary examination which revealed it to have fractured an off-hind toe and was stood down from racing for 42 days.

RACE 6 BBET PRICE BUMP GRADE 5 392m

1 GILDED GOAT – checked approaching the turn out of the back straight. Underwent a post-race Veterinary examination which revealed it had injured both quads and was stood down from racing for 14 days.

2 MADDY NORTHCOTT - a post-race swab sample was collected.

7 WINLOCK GUMMY - raced wide rounding the turn into the front straight.

2 MEAN CHARLIE - a post-race swab sample was collected.

4 OLLIE DOO – checked and fell approaching the 1st turn. Underwent a post-race Veterinary examination which revealed it to have injured its off groin and was stood down from racing 10 days.

5 OMAHRI ZEUS – checked and fell approaching the 1st turn. Underwent a post-race Veterinary examination which revealed sustained laceration to off fore dew claw and near hind toe and was stood down from racing for 10 days.

6 IT'S CASH TIME - checked approaching the 1st turn.

9 (Box 3) CUNDLE EMMA – checked shortly after the start.

RACE 8 ROYAL HOTEL TAREE PATHWAYS GRADE 5 (2) 314m

3 CLOUD SNIFFER – checked rounding the 1st turn.

4 DEVIL'S DIAMONDS – checked shortly after the start. Shifted out rounding out of the 1st turn. Underwent a post-race Veterinary examination which revealed no obvious injuries. Consideration was given to its actions approaching the turn into the front straight, the Greyhound was stood down from racing under Rule 71 "Unsatisfactory Performance" and must complete 1 satisfactory trial before returning to racing.

5 KUNG - checked shortly after the start.

6 DANGER BOY – checked approaching the 1st turn.

7 MEAN POP - a post-race swab sample was collected.

1 NOTHING TO SMART – raced wide rounding the turn into the front straight and made contact with the outside fence. Underwent a post-race Veterinary examination which revealed it to have injured its near fore wrist and was stood down from racing for 10 days.

3 ROCK ON BY - checked approaching the 1st turn.

4 GAGAN DOLLY - checked shortly after the start.

5 TEST OF TIME - checked approaching the 1st turn.

6 MINI MAGNATE - checked approaching the 1st turn.

2 HAWKEYE – collided with another runner entering the front straight.

3 OPAL SKY – checked approaching the 1st turn.

4 SIR ERSKIN – checked entering the front straight.

5 RAINING LADIES - checked approaching the 1st turn. Underwent a post-race Veterinary examination which revealed to have fractured left fore toe and was stood down from racing for 42 days.

6 DIAMOND QUEEN - checked approaching the 1st turn. Underwent a post-race Veterinary examination which revealed it to have a laceration to its near hind foot and was stood down from racing for 28 days.

7 GET UP ALLY - checked and fell approaching the 1st turn. Underwent a post-race Veterinary examination which revealed no obvious injuries.

3 RAVISHING RUBY - a post-race swab sample was collected.

7 TINY SPARKLE - checked shortly after the start.

8 BLACK MIKEY – checked and fell in the back straight. Underwent a post-race Veterinary examination which revealed no obvious injuries.

9 HE'S DEADLY – checked rounding the turn out of the back straight. Underwent a post-race Veterinary examination which revealed no obvious injuries.
