2 Rivello	Checked off heels in the early stages of the home straight on the first occasion. Came together midway through the first turn and moved out through the turn. Appeared slightly awkward in its action from this point on running wide in the turn to the back straight. A post race veterinary examination was carried out revealing abrasions to the left stopper pad, a spike injury to the right Dew Claw and right Hock pain - a 14 day incapacitation period was issued

A post race veterinary examination was carried out revealing no apparent injury.</p> <p>Stewards had concerns with the greyhounds actions in the home straight and whether it was chasing the lure with full commitment. Stewards interviewed the trainer Ms S Grey and after considering the submissions made, the result of the post race veterinary examination and a review of the race footage it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently no formal action was taken today but the Ms Grey was warned that future performances would be monitored and any similar behaviour may result in formal action</p>

2 Foran Banner	<p>Came together exiting the first turn and then checked off heels in the later stages of the turn to the back straight losing momentum on both occasions. Eased entering the turn from the back straight losing momentum and dropping back through the field before regaining momentum in the later stages of the turn from the back straight. A post race veterinary examination was carried out revealing a Left Hip Support Muscle injury - a 14 day incapacitation period was issued. After considering the result of the veterinary examination no further action was taken regarding the greyhound</p>

A post race veterinary examination was carried out revealing a fractured Right Hock- a 90 day incapacitation period was issued</p>
