<b>3 Sandra's Sticker</b>	<p>Commenced to give ground leaving the back straight to finish a considerable distance from the remainder of the field.</p> <p>Underwent a post-race Veterinary examination which revealed no apparent injuries.</p> <p>Stewards spoke with trainer Barry Howell in relation to the Greyhound's performance in tonight's race. Mr Howell said that he had recently altered his feeding regime for his Greyhounds which in his view may have contributed to its performance.</p> <p>After considering its overall performance in particular the amount of ground the greyhound lost in the back straight, it was stood down from racing for an Unsatisfactory Performance under Rule 129 and must complete 1 satisfactory trial before returning to racing.</p>

5 Bigbad Winnie	<p>Eased in its action and momentarily turned its head outward entering the front straight.</p> <p>Underwent a post-race Veterinary examination which revealed a small stomach muscle tear and was stood down from racing for 14 days.</p> <p>Stewards spoke to trainer' representative Ms Amy Brown regarding the racing manners in the front straight in which the greyhound appeared to ease and turn its attention to the greyhound to its outside. After taking submissions from connections, viewing all available video footage and taking into account the nature of the actions, Stewards issued a charge under the provisions of GAR 125 for Failing To Persue the Lure by way of Injury and must complete 1 satisfactory trial before returning to racing.</p>
