2 Cawbourne Ivy	Came into contact with the running rail at the turn out of the home straight. A veterinary examination revealed a Laceration to its N/S Hind Leg. Incap issued for 10 Days
6 Sneaky Blue	Had its heels galloped on in the back straight. Pulled up on the home turn and failed to finish. A veterinary examination revealed an injured O/S Monkey Muscle. Incap issued for 21 Days. Stewards considered the performance of the greyhound on the home turn and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue (first offence) under GAR124 and will be subject to a 28 suspension from racing at Wagga and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again
