After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Unsatisfactory Performance under GAR 129 and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.</p>
<b>2 Enough Power</b>	<p>In the run out of the home straight on the 1st occasion eased and shifted wide, losing momentum. A post-race veterinary examination was carried out revealing no apparent injury.</p> <p>Stewards considered the performance of the greyhound on the turn out of the home straight on the 1st occasion and interviewed the trainer's representative. <b>3 Santa Cruz</b>	Came together with another runner in the home straight and lost momentum. A post-race veterinary examination was carried out revealing no apparent injury. Stewards had concerns with the greyhound's actions in the home straight and interviewed the trainer's representative. After considering the submissions made and the result of the post-race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently, no formal action would be taken today but the trainer's representative was warned that future performances would be monitored, and any similar behaviour may result in formal action.
