A post-race veterinary examination was carried out revealing no apparent injury.</p> <p>Stewards considered the performance of the greyhound in the home straight and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Marring first offence under GAR123 and will be subject to a 28 suspension from racing at Temora and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.</p>
7 Apache Catori	<p>Badly hampered in the home straight when trying to shift inwards. A post-race veterinary examination was carried out revealing no apparent injury. Stewards had concerns with the greyhound's actions in the home straight and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently, no formal action would be taken today but the trainer was warned that future performances would be monitored, and any similar behaviour may result in formal action.</p>
