After considering the submissions made and the result of the post-race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently, no formal action would be taken today but the trainer was warned that future performances would be monitored, and any similar behaviour may result in formal action.
