The greyhound was also trialling in accordance with GAR101 in order to race with a weight variation of in excess of 2kg since its last race start on 31/07/23.</p> <p>As the greyhound has cleared over 350m it is now restricted in accordance with GAR132A to nominating for any distance up to 364m. A further satisfactory trial over a distance of at least 450m will be required to remove completely remove this restriction. A trial of 365-449m will clear the greyhound for distances up to 449m. In addition as the greyhound has not trialled at the track of offence it is now restricted in accordance with GAR132 to nominating at any track except Nowra. A further satisfactory trial will be required prior to racing at Nowra.</p>

6 Fine Scotch	Galloped on by another runner in the early stages of the turn from the rear curve and stumbled losing momentum. In the catching pen was found to have a suspected toe injury. A post race veterinary examination was carried out revealing a dislocated right hind toe- a 14 day incapacitation period was issued
