6 Stilton Lane	Checked off the heels of another runner at the point of the turn into the homestraight, colliding with that greyhound in the home straight.	
7 Despicable Cali	Hampered off heels soon after the start, at the tail of the field for the remainder of the race. Initial post race veterinary examination revealed no apparent injury. An initial veterinary examination by the OTV revealed a spike wound to the nearside hind for which no incapacitation period was applied. A subsequent veterinary examination by the OTV revealed an injured nearside groin for which a 21 day incapacitation period was applied. Stewards after reviewing the post race available footage had concerns regarding the greyhound striding out fully passing the changeover in the back straight and approaching the finish post. Taking account of the veterinary outcomes above, stewards took no further action.

RYAN'S CLEANING SERVICE 1-3 WIN, 520m

Collided soon after the start and came together with another runner in the home straight several times first time around. On entering the home straight momentarily hampered by another as it moved out from the rail, before colliding with that greyhound, then bumping with shoulder contact before chasing to the finish.

Initial Post race veterinary examination by the OTV and subsequent examination revealed no apparent injury.

7 Mason Here

Stewards after reviewing the race footage available could not conclusively determine if this greyhound had failed to pursue the lure in the home straight given the interference to it and the runner on its inner as they came together several times. Stewards concluded that in the absence of conclusive evidence regarding this greyhound not pursuing the lure soon after entering the home straight, that the greyhound be afforded the benefit of the doubt FTP. Stewards did however advise the trainer after the OTV examinations that a warning would be applied to this greyhound, such that if it were to repeat or exceed tonight's behaviour further action by stewards would likely follow. Stewards also took the opportunity tonight of recording this greyhound's behaviour in the Etrac database for future reference and review of performances near term.

Stewards spoke with the OTV to confirm the affect his findings might have in contributing to this greyhound's actions in the home straight. The OTV was of the view the injury would have been a significant factor in the greyhound's actions in the home straight assuming the injury, as it appears, was incurred in the home straight. Stewards took no further action.	
5 Miss Tess	Prominent early, coming together with several runners passing the changeover causing this greyhound and one other to fall and tail off. Post race veterinary examination by the OTV revealed no apparent injury.	
7 Domenico Flyer	Prominent early, coming together with several runners passing the changeover causing this greyhound and one other to fall and tail off. Post race veterinary examination by the OTV revealed no apparent injury.
