5 Awesome World	<p>Came together with another runner before falling when entering the first turn.</p> <p>A post-race veterinary examination detected no apparent anomalies.</p>
7 Bugatti Sargent	<p>Checked and became unbalanced when entering the first turn before colliding with another runner and losing substantial ground.</p> <p>A post-race veterinary examination revealed abrasions to the nearside fore and nearside hindleg. No stand down period was issued.</p>

After taking submissions from connections, reviewing all available footage and taking into account the nature of the injury, Stewards issued a charge under the provisions of GAR 125 (Failing to Pursue by reason of injury). As this was the greyhound's 1st offence it was suspended from Casino for the stand down period, which was 10 days and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
