1 Oscar Faith	Post race swab.
2 Unmatched	Last away. Came together with another in the back straight. Checked by another runner, which was hampered at the rail, ran out colliding with this greyhound and one other, this greyhound turned sideways and down in its hindquarters, losing considerable momentum and ground. Post race veterinary examination by the OTV revealed no apparent injury.
4 Ruby's Wish	Collided with another, shoulder only, in the home straight.
6 Keg On Legs	Led early. Checked by another runner, which was hampered at the rail, ran out colliding with this greyhound and one other, this greyhound losing considerable momentum and ground. Post race veterinary examination by the OTV revealed no apparent injury.
8 Major Johnson	Collided with another, shoulder only, in the home straight.

GREYHOUND CLUBS NSW MAIDEN, 297m	
1 Corless A Sailor	Post race swab.
2 I'm The Brodie	<p>Was boxed in the second row by the trainer Mr.Kraeft, who appeared to be having difficulty boxing the greyhound.</p> <p>Stewards consulted with the starter post race regarding the boxing of this greyhound, concluding in the view being formed the boxing was slow more related to the trainer than the greyhound.</p> <p>Stewards interviewed Mr Kraeft after the race. Mr Kraeft advised the greyhound had been subject earlier in its career to being boxed first and he believed today the greyhound had returned to its previous poor behaviour in being boxed. Stewards taking into account Mr Kraeft's submissions, directed today he was in receipt of a warning for not boxing the greyhound promptly in accord with the starter's directions and as a result this will be recorded in the E-trac database for future reference regarding the boxing of this greyhound. Stewards will review the boxing of this greyhound in the immediate future to determine what action might need to be invoked.</p>
5 Busy Going	<p>Checked in the back straight, going down in its hindquarters and yielding ground. Raced wide into and around the home turn a the rear of the field.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>

LABDROKES COMMUNITIES, 297m	
2 Zambora Blaster	<p>It was reported to the stewards post race by the starter that the trainer of this greyhound made intentional contact with his hand/arm with the roller door for his greyhound after it had been boxed immediately prior to the start. Steward's conducted an inquiry involving Mr Erwin later in the evening after reviewing the available video replays. Stewards asserted Mr Erwin had acted outside of GAR 105(10)(c) in hitting the starting box roller door as he moved away from the starting boxes immediately prior to jump. Stewards after taking Mr Erwin's submissions, stewards issued a reprimand penalty notice under GAR 156(f)(ii) given the circumstances, Mr Erwin's admitting to the offence and no prior penalties for similar.</p>

4 Rockstar Eilish	<p>Second favourite. Prominent early. Checked when competing for the lead leaving the back straight, stumbling, losing momentum and yielding ground. Post race veterinary examination by the OTV revealed no apparent injury.</p>
9 Isla Ville	<p>Began with the field at the start, yielding ground from the back straight to the finish without enduring any apparent interference. Post race veterinary examination by the OTV revealed an offside groin injury for which a 28 day incapacitation period was applied.</p>

RACE 10

PBD LADBROKES RACING CLUB 1-2 WIN, 297m

Stewards withheld all clear on this race pending discussion regarding the possible treatment of greyhounds 3 and 4 as follows. Stewards on reviewing the available video replays post race noted the muzzle of BROWNLOW FLYER (3) had caught, for part of the back straight, the racing vest of MISS TESS (4). Both runners had separated on entering the home straight. Stewards conferred and determined both were runners under GAR 110 (2)(b), with specific reference to whether they had had their chances in the event materially affected, when on leaving the starting boxes and mid back straight were placed last and second last in this short course 297m event. This decision making process was concluded with 'All Clear' given 10.13pm., 8 minutes after the scheduled race start time.

6 Pamjams Rocket

The starter advised stewards on enquiry, that the handler in placing this greyhound into the starting boxes was inconvenienced and delayed only momentarily from boxing in the second row by one of the greyhound's legs being entangled in her racing bib. With the assistance of the starter the greyhound was secured with minimal delay. Stewards took no further action given the extraordinary circumstances.
