RACE COMMENTARY

RACE 1	
LADBROKES MONTHLY MAIDEN HEAT 1 Maiden Series H, 365m	
At the boxes prior to being boxed a rabbit/hare was sighted on the course. Efforts were made by staff to remove the animal. This process delayed the start by 5 minutes over scheduled start time.	
2 Winds Of Georgia	<p>Midfield early. Leaving the home turn appeared to stargaze yielding ground. As losing ground came together with another, before noticeably easing in the home straight.</p> <p>A post race veterinary examination by the OTV revealed no apparent injury. Stewards interviewed connections after reviewing the available replays for the race culminating in the greyhound being endorsed for FTP 1st Offence under GAR 124 & GAR 127.</p>
3 Unmatched	<p>Raced wide rounding the home turn, appearing lost on the track momentarily on the exit to the home straight.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury. A second examination revealed nearside wrist soreness for which a 10 day incapacitation period was applied.</p> <p>Stewards interviewed their trainer Mr Bell regarding the greyhound's performance in rounding the home and issued a warning for Benefit of the Doubt failing to pursue the lure. Connections were advised this warning would be recorded in the Ettrac database and subsequent performances closely scrutinised.</p>
4 Cumbria Swift	<p>Appeared momentarily distracted by the runner very wide on its outer as it raced to the lead approaching the 520m boxes, coming together adjacent to the 520 starting boxes on entering the the straight.</p> <p>Post race veterinary examination by the OTV revealed soreness nearside chest for which a 7 day incapacitation period was applied.</p> <p>Stewards interviewed the trainer Mr Fitch regarding the greyhound's performance in rounding the home turn and issued a warning for Benefit of the Doubt failing to pursue the lure. Connections were advised this warning would be recorded in the Ettrac database and subsequent performances closely scrutinised.</p>
6 Miss Narla	<p>Was slow to be boxed due to the roller door on the rear of the boxes not moving freely. Starter provided the trainer with assistance.</p>

1 Sin Rap Unleash	Post race swab.
7 Gillenbah Tiger	<p>Collided with another soon after the start. Checked off the heels of another runner rounding the home turn. On entering the home straight moved up the track with what appeared to be a focus on the runner on its outer.</p> <p>Post race veterinary examinations revealed no apparent injury. A second examination revealed the same.</p> <p>Stewards reviewed the available race replays. and interviewed the trainer Mr. Reminis after the vet examinations. Stewards subsequently issued an endorsement for Failing to Pursue the Lure 1st Offence under GAR 124 and GAR 127.</p>

3 Runaway Ethics	<p>Appeared to glance the running rail in the run into the first turn.</p> <p>Post race veterinary examination by the OTV revealed no apparent injury.</p>
6 Ricky's Raiders	Post race swab.
8 Siska Lucy	<p>Trainer requested veterinary examination by the OTV post race. The examination revealed a lacerated nearside fore for which a 14 day incapacitation period was applied.</p>

AUSSIE INFRARED G.O.Y 2023 UNCLE DOUG, 365m	
1 Damage	Post race swab
4 Lightning Rocket	Yielded ground in running. Post race veterinary examination by the OTV revealed no apparent injury
8 Ashby Jet	Two runners came together on this greyhound's inner soon after the start, causing one of those runners to come together with this greyhound nearing the catching pen. As a result of this incident this greyhound pulled up at the 722m boxes where it was retained post race. Post race veterinary examination by the OTV revealed a fractured offside hock for which a 90 day incapacitation period was applied. After a period of treatment to stabilise the greyhound's condition it was transported to an industry approved veterinary clinic.

Stewards noted at the start a small (approx 10cm) strip of rubber normally affixed to the open face of the starting boxes or inside of the lid was flapping externally immediately prior to lidrise. Stewards were satisfied on video review of the lateral replay that the lids operated correctly and no impediment was experienced by any runner, declaring "All Clear".

1 Oscar Boaz	<p>Smartly away, leading towards the catching pen gate, at which point it made an audible yelp heard from the judges tower before quickly yielding ground into the back straight where it pulled up and was retained post race. It appeared another runner has likely glanced its hindquarters immediately prior to it losing ground passing the catching pen gate.</p> <p>Post race veterinary examination by the OTV revealed a fractured offside hock for which a 90 day incapacitation period was applied.</p> <p>After a period of treatment to stabilise the greyhound's condition it was transported to an industry approved veterinary clinic.</p>

OUT AND ABOUT DOG WALKING NOWRA PATHWAYS, 365m	
4 Stagger's Star	As a result of mistiming the start, slowly away.
7 Ebony Carat	<p>Checked the hind of another rounding the home turn. Was focussed on the runner on its outer approaching the point of the turn into the home straight where it turned its head outwardly towards MURPHYS PAW (3), hampering it significantly, another runner coming together with this greyhound at this time. In the home straight, came together with MURPHY'S PAW(3) again on its outer, possibly marring then mid home straight appeared to make head or muzzle contact with MURPHY'S PAW(3).</p> <p>Post race veterinary examination by the OTV revealed an injured offside chest muscle for which a 14 day incapacitation period was applied.</p> <p>After reviewing all available replays, stewards interviewed the handler regarding tonight's performance. The handler accepted the stewards determination that the greyhound had marred outwardly on at least one occasion in the home straight. Stewards issued a 1st Offence Marring endorsement in accord with GAR 123 and GAR 127.</p>
