<b>7 Sunset Charlie</b>	Raced tight with another runner over the concluding stages of the event. Stewards had concerns with the racing manners of the greyhound over the concluding stages of the event. A post-race veterinary examination revealed a strain to the offside tricep and a strain to the offside elbow and was stood down for a period of 14 days. Stewards took into account the nature of the injury when deciding against taking any further action.

## RACE 7

### LADBROKES SAME RACE MULTI 1-2 WIN, 411m

<b>2 Mr. Gledhill</b>	<p>Tightened for room before coming together with other runners when leaving the first turn, losing significant ground. Deviated its attention from the lure and shifted out and turned its head towards another runner when entering the turn out of the back section of the track.</p> <p>A post-race veterinary examination detected no apparent anomalies. Stewards spoke to trainer Mr. Tyreke Torrens regarding the racing manners of his greyhound when entering the turn out of the back section of the track. After taking submissions from Mr. Torrens and reviewing all available footage, Stewards issued a charge under the provisions of GAR124 (Failing to pursue). As this was the greyhounds' 1st offence in this category, it was suspended from Casino for a period of 28 days and must perform a Satisfactory Trial in accordance with GAR127(b) and pursuant to GAR132, before any future nomination will be accepted.</p>
<b>7 Kingsbrae Pumbaa</b>	<p>Encountered minor interference when entering the first turn and also when entering the turn into the front section of the track, finishing unplaced. Stewards noted a significant betting drift associated to the greyhound. Stewards questioned trainer Mr. Charles Northfield regarding the performance of the greyhound today. Mr. Northfield stated that the greyhound is a wide runner and isn't suited to Casino from the wide draw. Mr. Northfield further stated that the greyhound would compete predominately at other tracks moving forward.</p> <p>A post-race urine sample was obtained.</p>
