<b>5 Butker</b>	<p>Moved inwards approaching the finish and appeared to baulk losing momentum.</p> <p>A post race veterinary examination was carried out revealing no apparent injury</p> <p>Stewards had concerns with the greyhounds actions approaching the finish and interviewed the trainer's representative. After considering the submissions made, the greyhounds lack of race experience and the result of the post race veterinary examination it was decided that on this occasion Stewards would give the greyhound the benefit out the doubt. Consequently no formal action would be taken today but the trainer's representative was warned that future performances would be monitored and any similar behaviour may result in formal action</p>
<b>7 Fast Rock Harada</b>	<p>Came together with the lure rail exiting the back straight losing momentum.</p> <p>A post race veterinary examination was carried out revealing abrasions to the left elbow and Stifle - a 5 day incapacitation period was issued</p>

<b>2 Sorinder Bale</b>	<p>Turned its head outwards entering the home straight and moved out coming together with another runner. Then continued to run along the initial stages of the home straight with its head turned outwards towards another runner losing momentum coming together again shortly afterwards and then racing tightly to the finish</p> <p>A post race veterinary examination was carried out revealing a "spike" injury to the left fore toe- a 3 day incapacitation period was issued</p> <p>Stewards considered the performance of the greyhound in the home straight and interviewed the trainer Mr B Williamson. After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue (first offence) under GAR124 and will be subject to a 28 day suspension from racing at Richmond and will be required to complete a satisfactory stewards trial in accordance with GAR132 before being eligible to nominate again</p>

<b>Other Matters</b>	<p>Supplementary matter from Richmond race 4 3/3/24:</p> <p>Mr Troy Vella presented TASTY SNACK to be examined by the OTV after failing to present the greyhound post race last night. The greyhound was found to have nearside hip support soreness. 5 day incapacitation period issued. Stewards considered Mr Vella's explanation of the failure to present the greyhound yesterday and were content on this occasion to accept it was a consequence of a break down in the communication of the examination requirement.</p>

The injury and incapacitation information in this report was reviewed by the Veterinarian present at the meeting and confirmed prior to publication.
