All greyhounds underwent a veterinary examination prior to racing and all trainers were given the opportunity to withdraw their greyhounds from the event penalty free. Trainer Mr Brett Richardson (BALD HEAD SALLY) chose to do so and was withdrawn at 1.25pm. The starting boxes failed to open at the first attempt and the greyhounds were removed from the starting boxes and underwent a further veterinary examination and passed fit to start. All trainers engaged were given the opportunity to withdraw their greyhounds but no trainer exercised that option. The race commenced at 1.37pm via a manual start.

Other Matters	After the stir up for race 6 it was noted the lure cable had broken and remedial works commenced with an indefinite delay announced. After the failure of the remedial works the remainder of the race meeting was conducted under the safe chase lure system. All trainers were given the opportunity to withdraw their greyhounds penalty free. Trainers mentioned at the top of the report exercised this option. On course broadcast, sky Channel and wagering agencies were notified of the change. All races were delayed two time slots with race 11 rescheduled for 3.08pm and race 12 rescheduled for 3.23pm.  The automatic trips were retested following the running of race 6 after rectifying the issue. The remainder of the meeting was conducted via the automatic start.  All trainers engaged in races 11 and 12 were given the opportunity to remove and empty their greyhounds in accordance of rule LR86B.
