A post-race veterinary examination was carried out revealing no apparent injury. Stewards considered the performance of the greyhound on the 1st turn and in the home straight and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue first offence under GAR124 and will be subject to a 28 suspension from racing at Dubbo and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.
7 Wendy Ellen	Hampered on the 1st turn and again in the home straight. A post-race veterinary examination was carried out revealing no apparent injury.

After considering the submissions made, that the runner on the inside was shifting out and that his runner was trying to shift inwards and the result of the post-race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently, no formal action would be taken today but the trainer's representative was warned that future performances would be monitored, and any similar behaviour may result in formal action.</p>
