4 Send It Silver	A post race urine sample was collected
5 Credit Account	<p>Moved out passing the 100m mark coming together with another runner causing both to move out in close contact. Turned its head outwards shortly afterwards making head / muzzle contact with MAGIC HULK #3. A post race veterinary examination was carried out revealing a Left Pin Muscle injury - a 21 day incapacitation period was issued</p> <p>Stewards considered the performance of the greyhound from the 100m mark and interviewed the trainer, Mr A Shearman. After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Marring (2nd offence) under GAR123 and will be subject to a 28 day suspension from racing at all tracks and will be required to complete a satisfactory stewards trial in accordance with GAR132 before being eligible to nominate again</p>

4 Sicario Beast	<p>Moved inwards immediately after the start making heavy contact with other runners. The greyhounds head also moved inwards before straightening and chasing the lure. A post race veterinary examination was carried out revealing left shoulder and tail base soreness - a 10 day incapacitation period was issued</p> <p>Stewards considered the greyhounds actions at the start and spoke to the trainer's representative Ms J Howard. After taking into consideration this was the greyhound's second start at Richmond Straight, the first being with the side arm lure, Stewards could not be satisfied that the greyhound's actions could not been explained as initially looking for the side arm lure and the sharp turn of the head was not due to the impact with another runner. In light of this and the result of the post race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently no formal action would be taken today but the trainer's representative was warned that future performances would be monitored and any similar behaviour may result in formal action</p>
