After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue first offence under GAR124 and will be subject to a 28 suspension from racing at Dubbo and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.</p>

Other Matters	Race 2 DESTINI SEAHAWK was incorrectly drawn as the greyhound incurred a FTP1st Offence at Dubbo on 6/1/24, making it ineligible to race today. Race 5 FELONIES TWO (5) was incorrectly drawn as the greyhound incurred a 10 day incapacitation certificate from Dubbo on 6/1/23 making it ineligible to race today. As the fields had already been finalised the reserve WINLOCK HONDO could not be placed back into the field. Trainer Mr Len Haaring provided evidence for the injury of KARINYA CREEK from Race 5. Stewards have no further concerns. Race 5 KOTAH raced at Dubbo on 6/1/24 and suffered a injured stopper pad. The greyhound was presented and injury verified. Stewards have no further concerns.

The injury and incapacitation information in this report was reviewed by the Veterinarian present at the meeting and confirmed prior to publication.
