<b>3 Fire Fly Milo</b>	<p>Appeared to look outwardly in the home straight and came together with another runner. Collided with the catching pen gate post race. A post race veterinary examination was carried out revealing near side fore wrist laceration - a 21 day incapacitation period was issued</p> <p>Stewards considered the performance of the greyhound in the home straight and interviewed the trainer. After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Unsatisfactory Performance under GAR 129, and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.</p>

<b>2 Jacobite Farm</b>	<p>Slow to begin, checked off the heels of another runner into the first turn, shifted and forced wide, lost momentum approaching the catching pen the first time. A post race veterinary examination was carried out revealing groin soreness - a 7 day incapacitation period was issued.</p> <p>Stewards considered the performance of the greyhound approaching the catching pen on the first occasion and interviewed the trainer's representative Mr Kerr. After considering the submissions made and the result of the post race veterinary examination the greyhound was issued with an endorsement for Unsatisfactory Performance under GAR 129, and will be required to complete a satisfactory Stewards trial in accordance with GAR132 before being eligible to nominate again.</p>

<b>BLUE MEATS MAX 150 POINTS, 318m</b>	
<b>4 Tiggerlong Indi</b>	<p>Lost momentum approaching the first turn and tailed out. A post race veterinary examination was carried out revealing near side groin and off side tendon injury - a 14 day incapacitation period was issued.</p> <p>Stewards had concerns with the greyhound's actions approaching the first turn and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination it was decided that on this occasion Stewards could not be comfortably satisfied that the greyhound had breached any racing rules. Consequently, no formal action would be taken today but the trainer was warned that future performances would be monitored, and any similar behavior may result in formal action.</p>

<b>5 Tribute Bale</b>	<p>Checked off the heels of another runner and shifted wide shortly after the start, checked off the heels again on the turn into the back straight, shifted wide. Shifted and looked inwardly and came together with another runner in the home straight. A post race veterinary examination was carried out revealing no apparent injury.</p> <p>Stewards considered the performance of the greyhound in the home straight and interviewed the trainer. After considering the submissions made and the result of the post-race veterinary examination the greyhound was issued with an endorsement for Failing to Pursue the lure, third offence under GAR124 and will be subject to a three month suspension from racing at all tracks and will be required to complete two satisfactory Stewards trials in accordance with GAR132 before being eligible to nominate again.</p>
