Stewards were mindful of the greyhounds actions in the home straight, however on all the available evidence could not be comfortably satisfied that a breach of the rules had occurred. Notwithstanding this, Mr Rodgers was advised that the greyhound's future performances would be closely monitored.

Passing the winning post on the first occasion, became awkwardly placed between runners and checked off heels losing momentum. A post-race veterinary examination revealed no apparent injury. When questioned regarding the performance, kennel representative Mr Chris Perry stated that after being only fairly away the greyhound failed to display its usual early speed and was again further disadvantaged after having received a number of checks in running. Mr Perry added that although TOOTSIE TEARS has a record of 9 wins from 10 starts, it has yet to be tested under race conditions it experienced tonight, and believed it would derive benefit from tonight's run. He said that TOOTSIE TEARS had pleased in its work leading in tonight's event and the kennel had been confident of a forward showing, adding that it is the intention on the kennel to continue with the preparation.
