Immediately prior to being boxed at the start the lure arm moved a short distance towards the 520m starting boxes. Stewards, starter and lure driver conferred, the lure being reversed to its starting point whilst all greyhounds were retained behind the boxes at the start. The race started without further delay. Stewards inquired of the lure driver the circumstances pre race regarding the lure movement. The lure driver described to steward satisfaction the error made in the use of the lure controller. Stewards were satisfied with the explanation and took no further action.
