RACE COMMENTARY

RACE 1			
LADE	LADBROKES BLACKBOOK MAIDEN, 440m		
5 Hey Zeus	Making the turn out of the back straight shortened strides when appearing to become awkward within its action and lost ground. Thereafter, galloped awkwardly for the remainder of the race and finished a distant last. A post-race veterinary examination revealed minor abrasions to the nearside foreleg and offside hind leg. A 5-day incapacitation period was issued. Stewards interviewed trainer Mr Dean Maniaci regarding the overall performance of the greyhound, specifically in the manner whereby the greyhound lost ground on its own accord making the turn out of the back straight and the overall finish time. After reviewing all available video footage, taking into consideration the submissions made by Mr Maniaci and the veterinary report, Stewards deemed today's performance to be unsatisfactory. As a result, Stewards acting in accordance with GAR129 issued an Unsatisfactory Performance endorsement. The greyhound is now suspended from racing at Goulburn and until the completion of a satisfactory Stewards trial in accordance with GAR132.

6 Nikki Bonkers	Slow to begin. Soon after the conclusion of the race upon review of the race footage, Stewards observed the greyhound was placed away with the first line of greyhounds into the starting boxes. Stewards questioned handler Mr Declan Cooke in consultation with trainer Mr Neil Staines regarding the incorrect boxing procedure. After considering submissions made, Stewards reminded Mr Cooke of his obligations to ensure he adheres to the starter's direction when undertaking the boxing procedure before the commencement of the race. Stewards issued a verbal reprimand and took no further action.		
7 Shades Of Gold	When leading, making the turn into the home straight was galloped on from behind and lost ground. Appeared to weaken noticeably over the concluding stages of the race. A post-race veterinary examination revealed a laceration to the nearside hind leg. A 14-day incapacitation period was issued.

RACE 5

LADBROKE IT! 5TH GRADE 1-3 WIN HT 2 1-3 Wins H, 350m

The declaration of 'All Clear' was delayed to allow the Stewards to consider if any greyhound had been prevented from participating on equal terms with another starter in the Event in accordance with GAR110. After reviewing all available video footage and interviewing all trainers engaged in the event, it was established that Daytime Vera (1) had anticipated the start by lunging forward and contacting the front of the lids prior to the lure passing which resulted in the boxes opening slightly. Whilst it is acknowledged that the boxes opened slightly more towards box one, Stewards were satisfied that Daytime Vera (1) did not gain an advantage by the occurrence having regard to the manner in which it began, and the other greyhounds were not disadvantaged by also having regard to the way in which they commenced. Therefore, the Stewards were comfortably satisfied that all greyhounds participated in the Event on equal terms and furthermore, no greyhound was materially prejudiced or affected to such an extent to declare the event a No Race or Non-starter. As such, the Stewards declared the event a race and the 'All Clear' was given.

When leading the race, shortly after entering the home straight eased within its action, turned its head outwardly twice, losing its leading position, ultimately failing to pursue the lure before regaining momentum and finished the race strongly. A post-race veterinary examination revealed no apparent injury. Stewards interview trainer Mr Michael Hardman regarding the greyhound's mannerism's shortly after entering the home straight, specifically in the manner whereby it eases when leading the race and stops pursuing the lure. After 4 Ballow's Revenge reviewing all available video footage, taking into consideration the submissions made by Mr Hardman and the veterinary findings, Stewards issued an endorsement for Failing to Pursue in accordance with GAR124. As this is now the greyhounds second offence, the greyhound is now suspended from racing at all tracks for a period of 28 days and until the completion of a satisfactory Steward's trial in accordance with GAR132. A post-race veterinary examination revealed a nearside back muscle strain and offside groin soreness after the greyhound began to lose significant ground **6 Twisted Kisses** shortly after the start and became detached from the field, finishing the race a long distance behind the field.
